### Container Size

1 LITRE (Only a tiny amount is needed for each application).

## Application

- Using a finger or trigger spray, apply a couple of 'squirts' on the floor or wall behind the toilet and near the urinal or basins to leave a lingering fragrance.
- Avoid spraying on floors where people walk or on any surfaces subject to skin contact.
- Avoid spraying near pilot lights, flames or other ignition sources.
- Apply strategically in other rooms, for example, spray in opposite corners.
- A couple of squirts into a garbage bin will mask unpleasant odours.
- Note that a residue will exist for a couple of days, but will gradually evaporate. This residue is necessary as it provides the perfume source.
